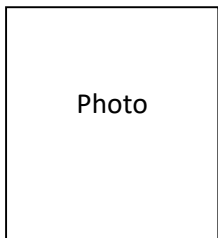

- 1. That I am qualified in terms of Section 5A of the Legal Practitioners and Bar Councils Act 1973 which is reproduced as under:-**

Section 5A:- Qualification for membership of a Provincial Bar Council and Islamabad Bar Council:-

A person shall be qualified to be elected as a member of a Provincial Bar Council and Islamabad Bar Council if he:-

- (a) *is on the roll of advocates of High Court maintained by the Provincial Bar Council¹ and Islamabad Bar Council, for not less than five years and*
- (b) *has, on the day of filing of the nomination paper, been an advocate for not less than fifteen years; and*
- (c) *has cleared all the dues payable by him to the Provincial Bar Council²[and Islamabad Bar Council*

Provided that for the first election of Islamabad Bar Council, the qualification required for a candidate for Punjab Bar Council shall apply to the candidate to be elected for Islamabad Bar Council.

2. That I am not disqualified in terms of Section 5B of the Legal Practitioners and Bar Councils Act 1973 which is reproduced as under:-

Section 5B:- Disqualifications for membership of a Provincial Bar Council and Islamabad Bar Council.—

A person shall be disqualified to be elected as a member of a Provincial Bar Council and Islamabad Bar Council if he-

- (a) *was dismissed or removed from the service of Government or of a public statutory corporation; or*
- (b) *has been convicted for an offence involving moral turpitude; or*
- (c) *has been found guilty of professional misconduct; or*
- (d) *has been declared a tout; or*
- (e) *is an undischarged insolvent.*

3. Nomination form fee Rs. 35000/- (non-refundable) is deposited in the General Fund Account of the Khyber PakhtunKhwā Bar Council. (copy attached)
